County Elias Alford Sen. a resident of Hall County
of State of Georgia aged seventy five years the 6th
day of May last a quaker to a record of his
age kept by his parents who being first
duly sworn according to Law then on his

Oath make the following declaration in
order to obtain the benefit of the provision
made by the act of Congress passed June
7th 1832. That he entered the service of the
United States under the following named
Officers and served as hereinafter stated.

That he was drafted into the service of the
United States about the first of December in
the year nineteen hundred and eighty for
a three months tour of duty under Capt
John Hines who commanded a company of
Horse (depot furnished his own horse) and
was attached to Colo John Lettells Regiment
Major G. ^{Hotelton} also belonged to said Regiment
and was ^{major} while Gen. Green's army were
stationed near the Cheraw Hills in the State
of South Carolina. from thence we marched
up Pedee River to Salisbury in North
Carolina leaving Gen. Green with his army
to follow we made a rapid march to
meet Math and after Colo Morgan ^{who} was
retreating from Wallis after having defeated

Patton at the Croopers) When we reached
Salisbury we found Col. Morgan with his army
marching through town. Who placed the company
of Cavalry to I belonged together with about
eighty of his riflemen to guard until the
main army could be ferried across the
Yadkin River. Just about the time
the last baggage Wagon got on board the
Flat a party of Wallis men said to be
about one thousand came upon ^{us} We fired
two rounds and retreated and on the next
day joined Col. Littel marched to the
Barracks and in two or three days was discharged
the time for which I was drafted having expired

This a few days after getting my discharge
I substituted in place of a man by the name
of John Litten for a three months tour of
duty in the Cavalry again and under
the same officers and was marched to Vero
through the State of North Carolina Slapping
down the Tories and was in our party Smart
Minnick with the ^{which was} ~~the~~ Commanded by a Col.
Fanning a noted Tory. I think this tour of duty
was commenced about the first April 1781. having
served out this tour of duty. I with several
others of the same Company agreed to stand as
what was termed minute men subject to the
call of the same Captain and was frequently
called on and was out sometimes two or three
days at a time. I have no documentary evidence
and know of no person by whom I can prove any
service except John Duncan whose affidavit is
annexed. I hereby relinquish every claim to a

pension or annuity except the present and declares that
his name is not on the pension ^{rolls} of the agency of
any state

1 I was born the State of North Carolina but am
not positive whether in Randolph or Orange
County on the 6th day of May 1758

2nd I have no record of page ^{my} though I have seen
one made by in Book kept by my father
which is worn out or lost.

3 I was living in Randolph County North
Carolina when called into service; I remained
in the State of North Carolina until the year
1815. then removed to the State of South Carolina
Pendleton District. remained there until the
year 1827. then removed to Hall County
State of Georgia where I now live.

4 I was drafted into the first tour of duty
and the second I substituted.

Dear Madam:

Reference is made to your request for information relative to Revolutionary War soldiers, John Byrd, Francis Foster, Malone Mullins and Elias Allred.

Because of the large number of requests for records of Revolutionary War soldiers and the lack of clerical force available for furnishing such information, it has been impossible to comply in full with requests similar to yours. The record of Elias Allred is furnished herein.

The data which follow were taken from papers on file in the pension claim, S.16307, based on the military service of the only Elias Allred that is found in the Revolutionary War records of this office.

Elias Allred was born May 6, 1758, in Randolph or Orange County, North Carolina. The names of his parents are not shown.

While residing in Randolph County, North Carolina, he enlisted about December 1, 1780, and served three months in Captain John Hines' company of horse in Colonel John Littrell's North Carolina regiment. He enlisted about April 1, 1781, and served three months under the same officers and was in a skirmish with the Tories. He afterward served at various times on short tours of ~~service~~ three days each under Captain John Hines of the North Carolina troops, entire length of this service not given.

After the Revolution, Elias Allred continued to reside in North Carolina until 1815, when he moved to Pendleton District, South Carolina, where he lived until 1827 when he moved to Hall County, Georgia.

The papers in this pension claim contain no data relative to the family of ~~Elias~~ Allred.

In order to obtain the date of last payment of pension of this soldier, the name and address of person paid and possibly the date of death of the pensioner, it is suggested that you address the Comptroller General, General Accounting Office, Records Division, this city, citing the following data:

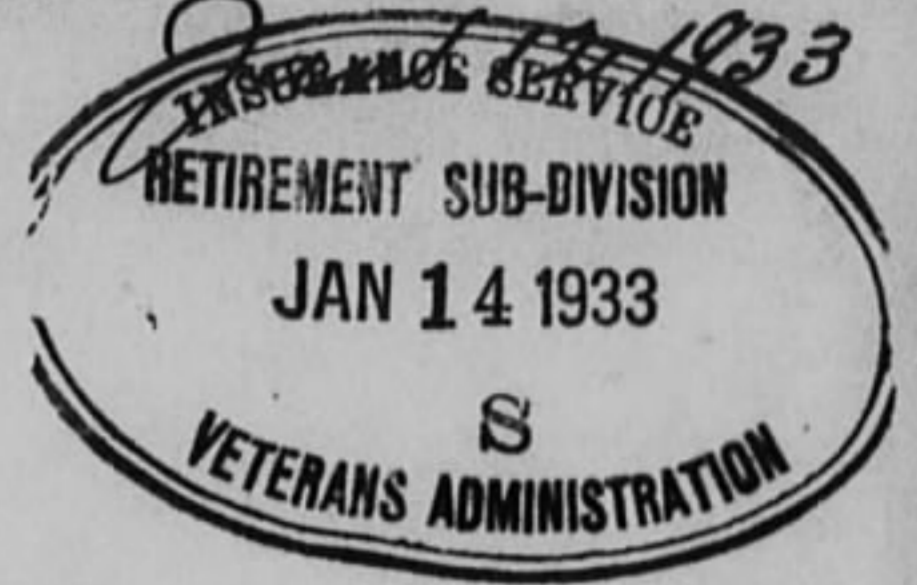

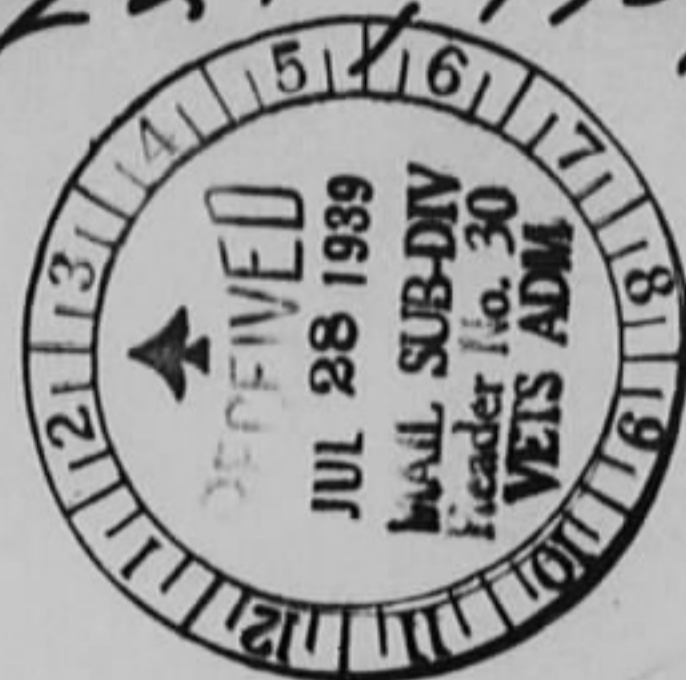
