

ALLRED RESEARCH UPDATE

I would like to begin this address by giving the readers of the family newsletter a bit of background concerning myself, my family and my interest in the Allred family. My grandmother was Amanda Adaline Allred, daughter of Ephraim L. Allred and Harriet Brunson. I was born in Utah and have always had an interest in family history, the "whys and the wherefore's." How did I come to be born in the desert? How did my ancestors get here and where did they come from? For years I have dabbled in history and genealogy, but our search for the truth concerning the origins of the "Allred Family In America" began a couple of years ago when Earlene Allred Smart and I began to look at the compiled records of earlier researchers and started our own project of collecting and analyzing information. This was no small task. Some of you have access to a small publication called, "John of Orange" (Dawnell H. Griffin) which was the result of a multitudinous number of hours of hard work. We were able to identify many of the family relationships for our North Carolina family that had never before been linked and we verified much of the research of the past. This was a workbook, however, and never meant to be the final word. Our findings took us back to the earliest records wherein we could say with accuracy "our lineage is proven" and to the year 1756.

There have been attempts by qualified researchers to prove our English origins, but never any positive proof. The publication by R.C. Allred "The Allred Family in America" which for many years has stood as the only authority on the subject, contains the work done by Archibald F. Bennett, wherein he states his hypothesis and includes not a "few probabilities." And so our work began. Let me say again that if this had been an easy task, it would have been completed long ago. I cannot tell you how many times I have felt stretched and stressed to the limit. I have asked you to be patient, and so you have been, but I must ask your continued indulgence as I lay before you my own "preponderance" of evidence.

This does not mean that we have not worked diligently or

that we do not believe our findings! It means only, that to date, this is the best evidence that we have and until we have found documentation to disprove our beliefs, we are willing to accept the evidence before us, at least as a point of reference

with which to continue our efforts.

Archibald F. Bennett stated that the Therefore: Alred/Aldridge Family were one and the same and that our ancestor, John Allred, was born in Virginia and migrated to Orange County, North Carolina. In the beginning, I researched the Allred/ Aldridge names as they were listed in Burke's and other authoritative books on nomenclature and could find not one reference where the two names were used interchangeably. In addition, there were researchers who questioned the findings of A.F. Bennett, who took issue with him at the time he was doing his research and who had serious doubts as to his findings. I mention the name Memory Lester, as one who spent a life time in pursuing her Aldridge lines. Earlene and I looked at the records of the Aldridge family and could not see any concrete evidence that this was our family. What we did find, was that there was a William Allred and a William Aldridge living in Orange County, North Carolina and that they were two separate and distinctly different men with two individual families.

I know that it has been difficult for some of the members of the family to accept the fact that our genealogy is "not all done." Considering that the "Aldridge" line goes back to the 1500's, the 1756 date seems a little inadequate to say the least. Nevertheless, anything beyond that point (until the most recent research) is all that we can legitimately claim. I can now safely say that we have added at least 6 years to that date, another county and another state (which by the way is

not Virginia for the time being).

For those of you who are not familiar with the Allred men who founded Orange County, they were John and his four sons Thomas, William, John and Solomon. There has been little dispute about these relationships and it is this premise that we have accepted. That being so, we are looking at all the evidence concerning this family that we can find.

We have the statement of William's grandson that tells us William was born and raised to manhood in Pennsylvania. This was and is a valuable clue. We have the names of Solomon's children, unusual names which also gave me some hope in discovering our ancestry as these names also appear in a family in Lancashire, England. [This has now irrefutably been proven!] With the names of witnesses on land deeds, probate records, tax lists, road surveyors etc. we have identified neighbors and kinsmen. There are helpful county histories and biographies. We know that people migrated in family groups and with friends and neighbors. These are the reasons I cite for giving evidence that we are not Aldridge's from Virginia, but Allreds from Maryland and Pennsylvania and a generation (or two) before, Lancashire, England.

As I continue, you need to be aware that our family were farmers and craftsmen. I can find no evidence, I repeat, no evidence that ours is an armigerous family (one entitled to bear a coat of arms). Our ancestors were poor. They worked and struggled to stay alive and to provide the necessities of life for their families. They worked hard. They were honest and they were religious. The fact that they were not nobility or gentry does not diminish their value, but may indeed

enhance for us the values that they held dear.

I do not hold forth any hopes or beliefs that the answers to all our questions will come easily or effortlessly. The records that now remain for us to search are, for the most part, un-indexed and tedious. Many of you have offered to help with this project. At this point, one sentence, one clue is enough incentive to keep going.

In my own defense please accept my contribution in donated hours as comparable to any other member of the family who has contributed to this effort. Those of you who are acquainted with the process will surely recognize, that the

effort made has been an honest one.

Now for something a little more concrete. For the first time since the publication of A.F. Bennett's work, we now have two documents that place at least one of the five men listed previously of Orange County, North Carolina, in Frederick County, Maryland. I will give this information as it has been transcribed:

At the Request of Robert Evins the following supersedeas was Recorded October the twenty fourth Day Anno dom Seventeen Hundred and fifty (viz)Fred.[Frederick] County//You William Alred Thos. Heley & Joseph Tomlinson do Confess Judgements to Robert Evins for the Sum of four pounds six shillings & nine pence curent money which sum was Recovered by the said Robert Evins against William Alred on the sixteenth Day of June 1750 before Joseph Chapline one of his Lordships Justices of the peace for the County aforesaid the said sum of one pound six shillings & nine pence to be [off the page] Your Bodies goods and Chattles lands or Tenements for the use of the said Robert Evins in case the said William Alred shall not satisfie & pay the sd Robert Evins the said one pound Six Shillings & nine pence so as aforsd. Recovered against him with the additional Cost thereon on the tenth Day of February next taken beforeJoseph Chapline

The second document is an Indenture wherein William Alred sold to Charles Higgenbothom, both of Frederick County, two tracts of land; one called "Bedlam Green" and the other "Pile's Delight." The transaction took place in 1752, but so far the date and circumstance of the original purchase has not been found. In an effort to do so, I have searched the records at the Family History Libray in Salt Lake City and I have written to the County land office, but with no results. Again, in order to find an answer I concluded that it will require a search of un-indexed court minutes, a process already well underway. To say that this is a "time consuming process," is not an understatement.

As I have proceeded I have found enough evidence that I feel the project is worth pursuing. I realize that some of these names will hold little meaning for some of you, but I believe that Earlene will be able to support me with not just a little enthusiasm. Included in these records were the following entries:

1.A request from $\mbox{\sc Wm}$ Willburn to register his brand on his Cattle and

Hogs. 1748

2.A request from Joseph Wood [same]. 1848

3.Indenture between Charles Cheney and John Rutter for 47 acres of land.

The witnesses were Joseph Chaplene and Charles Higgenbotham. 1748

4.Capt. Charles Higginbotham bought land from Wm & Lidia Flintham.

The witnesses were Thomas Scarlett and James Beason. 1749

5.Henry Touchstone and wife Sarah sold land to Richard Touchstone, 1749.

6.Wm Gatlin sold land to Danl. Touchstone.

7.Richard Touchstone sold land to Geo. Moore, a tract called "Cheney."

8.Thomas Thrasher, planter, sold property to the Reverend John Eversfield.

[This has been copied in it's entirety].

9.Joseph and Mary Ogle sold land to Larrance Crager. 1749

10. Joseph Wood registerd his brand. 1750

11. William West vs Capt Wm Griffiths & Saml Darmour in civil court.

12. Charles Chaney jr. registered brand.

13.Caleb Touchstone sold a negro boy to Danl. Touchstone.

The witnesses were: Stephen Touchstone and Richard

Touchstone.
14.Thomas Odell bought land from Jeremiah McGruder of

Prince Geo. Co. 15.William Trogdon, John McFaddon & Stephen Petcock vs. Geo. Gordon

in a suit concerning 60 pounds of tobacco.

16. There are other interesting names, i.e. Hopkins, Brooks, Hunter etc.

These names become significant when placed in relationship to the records we have found in North Carolina i.e. Solomon Allred bought and sold property to Stephen Touchstone. The Trogdon family history states that the first Trogdon family in America was that of William Trogdon. Let me quote:

The Trogdon ancestors all hail from a grange of that name in Woodland, near Ulverstone, Lancastershire, England....When the records in America are traced there are found very few leads to work upon...In the first census of the United States, that of 1790, there is no reference to the name of Trogdon in any State except North Carolina, where are found names of four families of Trogdons in the list covering Millboro district of Randolph County.

In 1762, Thomas Alred and Wm. Trogdun were chain carriers for James Mickleroy who bought property on Sandy Creek. This is only one instance of the Allred association with the Trogdon family. Add to this evidence the history of the York family. Thomas Allred and Henry York were next door neighbors (that does not mean that there weren't a few acres between them). They appear as overseers of the road side by side and their land lay side by side. Henry York's grandson stated that he was born at the Pipe Creek Settlement. In the history of the York family, Pipe Creek was given as a settlement in Carroll Co., Virginia which place, by the way, does not exist. However, there was a Pipe Creek Settlement in Carroll Co., Maryland which at the time of Henry York's birth (according to bible records) was interestingly enough...Frederick County, Maryland. [Another source says he was born in England and resided at Pipe Creek.]

I have only one more piece of evidence to display for the present. No one has ever questioned that there is a family relationship between Solomon Allred and the other Allred's of Orange County, N.C. and it is much to my advantage to do likewise. (Unless positively proven

otherwise of course). The Allred family, not lacking in offspring, had little imagination when it came to naming practices, except for Solomon. The name Solomon itself does show up in Thomas' family (thank heaven) and vice versa. Solomon and Thomas did sign for each other on documents. But the point is, Solomon named his children, "Phineas, Solomon, Jonathan, Francis, and John. Solomon also had two grandsons named "Theophilus." There is in Lancashire, England in the late 1600's, a John and Ellen Pemberton Allred whose children are listed in the Eccles, Lancashire parish registers as "John, Mary, William, Alice, Phineas, Enoch, Theophilus, Ellin, and Solomon Orred." As there are no other "Orred's" listed for Eccles parish I feel safe in assuming that the name change is a clerical error. John and Ellen, the parents, appear positively in other documents with the name "Allred" intact. I found a reference to this family some time ago which cited the Newbury Library in Chicago, but whose records are not available at the Family History Library in Salt Lake City. Since I had found references to John and Ellen, but could not locate any positive proof concerning their children, I asked Dr. V. Ben Bloxham to check the records in England last summer. He found the information on the parish register and returned with positive proof that this family does exist, complete with christening dates.

As you can see the bridge between Maryland and Pennsylvania will take a lot of work and there are no guarantees. I can only state the case as I see it. There is nothing to indicate that the name Allred was ever "Aldridge." There is nothing to link us with the Aldridge family of Virginia with the exception of Thomas, Jr. who married Margaret Aldridge. There is concrete evidence now that at least William resided in Frederick County, Maryland previous to his migrating to Orange County, North Carolina and there are a great many authorities in the field of genealogy who place credence in family naming practices. There are associations with neighbors who in all likelihood migrated together from one place to another. The proofs are few in number, but the preponderance of evidence is as straightforward and intriguing as any I have yet seen published. Getting our family from America to England is probably the hardest task of all, but if we can prove this lineage there will be some who will be happy to note that the Pemberton family is one of high repute.

I am nearing the completion of the task of organizing the records I now have in my possession. The Allred Family Organization will oversee the availability of those documents. I know that there are qualified researchers in our family and we would be very happy to have any assistance. However, Levi, Moses, Elias and Eli were not four brothers who immigrated to America from Norfolk, England. They were Thomas' sons. They probably never saw England. This does not constitute a major break through. It is very late and I am very tired or I probably would not have made that last statement.

ALLREDS IN THE NAUVOO LEGION

In 1841, the mormons in Nauvoo organized a militia, or using the Roman Army term, a legion. Tired of being persecuted by mobs and realizing the need for self-protection, Joseph Smith authorized John C. Bennett to secure a charter for the military unit from the state of Illinois. This being done, the Legion was duly organized in February, 1841, with officers being elected at that time. Joseph Smith was approved as Lieutenant General and John C. Bennett as Major General. Among those other staff officers elected that day was James Allred, who was elected a guard and Assistant Aide-de-Camp. James, then 57 years of age, later called as a member of the Nauvoo High Council, was a highly respected member of the Church and the community.

An Aide-de-Camp held rank as Captain of Infantry but acted as secretary and confidential assistant to General Smith, as a member of his personal staff and as his personal

bodyguard.

Over the next few weeks the Legion gradually took shape, The eventual total evolving into two coharts or brigades. enlistment of men by 1844 was some 3,000. The First Cohart, commanded by Brigadier General Wilson Law, consisted essentially of horse troops, while the Second Cohart, essentially foot soldiers, was commanded by the Prophet's younger brother, Don Carlos Smith until his death in August of 1841 and then by Charles C. Rich.

As far as I can determine, no complete list or records exist for the soldiers of the Nauvoo Legion. Likely some records have been lost; likely some records that do exist are incomplete but no records at all are available for the enlisted men of the Legion. Undoubtedly many of the younger Allreds served as soldiers, even though I cannot verify that.

Following is a list of those Allreds who served as officers in

the Nauvoo Legion:

1. James Allred, Captain, Aide-de-Camp from March, 1841

2. Issac Allred (I presume this is James's son, Issac, rather than his brother, Issac, since the son mentions his involvement as an officer in the Legion in his journal.) as Captain in the 5th Regiment of the Second Cohart from July of 1842 on.

3. Reuben Warren Allred (son of James) as a 3rd Lieutenant in the 1st Company of the 1st Battalion of the 3rd Regiment

of the Second Cohart, from September of 1842 on.

4. Wiley Payne Allred (son of James) as a 3rd Lieutenant in the 2nd Regiment of the Second Cohart from April 1842 on.

5. William Moore Allred (son of *Issac) as, in succession, a 3rd Lieutenant, 1st Lieutenant, and Captain in the 1st Company of the 2nd Battalion of the 1st Regiment of the

Second Cohart from March of 1841 on.

James (most likely James Anderson Allred, son of William, who's age best fits, although both James and Issac also had sons names James {James T.S. and James Riley respectively) as 3rd Lieutenant in the Second Cohart from September of 1844 on.
7. In addition, Allen Taylor, Son-in-law of *Issac, married to

his daughter, Sarah Lovisa, as a 2nd Lieutenant in the 1st Company of the 2nd Battalion of the 1st Regiment of the

Second Cohart.

At the death of the Prophet, Brigham Young was elected as commanding officer of the Legion . However, in January of 1845, the Illinois State Legislature repealed the charter of the Legion and legally dismantled it. In spite of the legal action, the Legion still trained, still did guard duty, and mustered for possible attacks by mobsters. As Nauvoo fell, the Legion did. Later on the exodus to the Great Salt Lake, the Legion was reorganized and existed in Utah in some form until 1887.

WHITLOCK

I keep waiting to see if someone will send something in on the Whitlock family. Since that has not happened, I decided to write something on them myself. Even though they are

not my direct line, they interest me.

Andrew Hyrum Whitlock was James Allred's son-in-law. After the death of his wife, (Hannah Caroline Allred, who died in 1850, Council Bluff, Iowa) Andrew and his family came to Utah with James and in 1851, followed him to Sanpete county. They spent the winter of 1851-52 in Spring City, but because of Indian troubles, were forced to abandon the settlement. Andrew went to Manti where he resided until 1854, when he and his family, consisting of three sons and five daughters, moved to Ephriam. They assisted in building the fort (Fort Ephriam) and took part in the Indian Wars. One son, Andrew, was wounded by an arrow, but recovered. Another son, Charles, was a saddle and harness maker. The Whitlocks were prominent Ephriam citizens.

The family remained in close contact with James Allred and family. They are mentioned as attending most gatherings of the Allreds. In 1853, Charles Whitlock married Caroline M. King in Spring City. Andrew Hyrum

Whitlock died in 1865, leaving many descendants.
Children of Andrew Hyrum Whitlock and Hannah Caroline Allred; Sally Ray Whitlock, died Cleveland, Ut, married (1) Mark Rogers, (2) Henry Herman Oviatt; Mary Jane Whitlock, died Ephriam, Ut. married (1) John Franklin Oviatt, (2) Thomas Peter Peterson; Charles Whitlock, died Ephriam, Ut. married Caroline Matilda King; James Hardin Whitlock, died Junction, Ut. married (1) Margarette Ann Voorhees, (2) Sarah Eliza Elvina Allred; Elizabeth Ray Whitlock, died Ephriam, Ut. married Henry Barnabus Stevens; Nancy Mariah Whitlock, married Ira A. Oviatt, perhaps married (2) William Beal; Thursa Malinda Whitlock, died Cleveland, Ut. married Lewis Larson; Andrew Hyrum Whitlock, died Salt Lake City, Ut. married (1) Andrear Nielsina Overlade, (2) Ann Marie Draper.

At the present time, there is not one Whitlock listed in the telephone book in Ephriam. However, there are Whitlocks in the Gunnison, Centerfield and Mayfield areas. Perhaps, one of the descendants will read this and send the AFN a more

personal history, along with a picture or pictures.

We would like to have any descendants of these families at the Allred Family Reunion in Spring City, Utah on June 27. 1992 !!



Major Leron H. Allred

Major Allred was born in Afton, Wyoming on May 5, 1937. His parents are Zenneth Woodrow Allred (Edwin Nelson Allred, Medwin Newton Allred, William Moore Allred, Isaac, William, Thomas, John) and Wilda Viola Hokanson Allred, both Star Valley Wy. natives.

In June of 1959 Leron graduated from the University of Wyoming with a BS degree in geology and a commission in the U.S. Air Force. After successfully completing jet pilot training he served at Tyndall AFB, Florida; Eielson AFB, Alaska; Udorn AFB, Thialand; Sheppard AFB, Texas; Hill AFB, Utah; and Elmendorf AFB, Alaska.

During his 20 year career he flew mostly helicopter aircraft

During his 20 year career he flew mostly helicopter aircraft and amassed 6800 hours of flying time. Among his many awards and decorations are the Distinguished Flying Cross (DFC), Meritorious Service Medal, 6 Air Medals (4 combat and 2 peacetime), Bronze Medal, Air Force Commendation, Presidential Unit Citation and the Vietnamese Cross of Gallantry.

The DFC was awarded after a daring helicopter rescue mission on 14 Sept. 1968 in North Vietnam. He flew his unarmed helicopter in adverse weather and rugged mountain jungle terrain to make an emergency recovery of seven survivors of a friendly intelligence team which had come under enemy attack.

In November of 1979 he retired from the Air Force and returned to his home town of Afton where he and his wife are presently operating a successful beef cattle ranch

ALLRED FAMILY COAT OF ARMS

Recently I have done a lot of research in numerous British Heraldry and Visitations books to verify the authenticity of the Allred Coat of Arms. This research uncovered many interesting facts that may not be too well known to some of our family members, and so I would like to share them with you.

In 1584/85, during the Visitation of Yorkshire by heraldic messengers, a coat of arms was granted to and signed by one John Alred of the Charterhouse, near Kingston-Upon-Hull, in the East Riding of Yorkshire. He signed the Visitation pedigree of his family as JOHN ALREDE. John was the son of Thomas Alred, a gentleman and Minister of the Long Parliament for Kingston-Upon-Hull in 1557-1558; he was also the mayor there in 1561. When King Henry VIII visited Hull in 1541, he commanded a thorough repair of the manor house, formerly known as Suffolk Palace. Thomas Alred came to Hull to fulfill the position of the paymaster-general of these fortifications. Later the Alreds acquired the site of the Carthusian Priory and built the house which later became the residence of Thomas and his progenitors. It was also the Governor's residence and is now YE OLDE WHITE HARTE INN, off Silver Street in Hull. Thomas was the son of Roger Alred of Tannington in County Suffolk, who was said to be "of good antiquitie".

The coat of arms granted to John Alred of Holderness Wapentake in Yorkshire, was: Gules (red), a chevron engrailed between three griffins' heads erased argent, beaked or (gold). The Allred Family Organization still has about 25 beautiful 8x10 color reproductions of this armory and they are selling them for \$3.50 each (including postage and handling). Additional coats of arms will be printed and will be on sale at the Allred Family Reunion in Spring City in June.

Although we have not as yet been able to tie our family pedigree directly to this John Alred family of Yorkshire, we are certainly justified in adopting their coat of arms to represent our Allred Family. Present research being done seems to take our Allreds back to Eccles, Lancashire, which is approximately 80 miles from Hull.


To put it more simply, this Alred pedigree runs from father to eldest son as follows: 1. Roger Alured/Alred of Tannington, County Suffolk; 2. Thomas Alred of Charterhouse near Kingston-Upon-Hull, living in 1584; 3. Henry Alred, born about 1581, of Charterhouse; 4. John Alred, born about 1607. The two sons of Henry Alred (#3), i.e., John and Matthew Alred were very prominent Colonels in the Civil War of England. John was one of the Members of the Long Parliament who signed the warrant for the execution of King Charles I.

Hopefully we can tie our ancestral line to this Alred family, but if not, at least we can take pride in their prominence and service to their country and the cause for which they stood— and especially in the way they honored our Allred Family name.


