My name is Melvin and I'm a one L. I grew up thinking I had two L's. All the Allreds I knew had two L's. My mother, father, brother and sisters had two L's.

At the age of 18, I decided to go into the Air Force. The recruiting sergeant said I would need a birth certificate. I asked my parents about a birth certificate. They told me that had never seen one, but the doctor that came to the house to deliver me asked a few questions and filled out some papers.

So I went to town and at the doctor's office I was told I could get a copy of my birth certificate at the health department.

After getting the birth certificate, I took it to the recruiting office. When the sergeant began to

fill out the necessary papers, he said that is M-E-I-V-I-N A-L-R-E-D. "No sir" I answered, "That's A-L-L-R-E-D." "Well" said the sergeant, "there's only one L on your birth certificate."

I couldn't believe it, with the stroke of a pen, the doctor had surgically removed one of my L's at birth. This was the first I knew that I wasn't a complete Allred. I confronted my parents, but they said they never noticed anything wrong with me.


### John James Allred

John James Allred (June 1, 1824-after 1890) is one of our mystery Allreds. He and his brother, Masten, were the ancestors of Jim Allred, Reston, VA (AFO Research Representative) and Melvin Alred, Rome, GA (AFO Georgia Representative). Jim and Melvin believe John James and Masten were probably the grandsons of the "original" Thomas. This is why:

1. Per census records John James' mother was born in South Carolina. James, grandson of Thomas, married Elizabeth Warren (1786-1879) of Spartanburg, SC. They were the right age to have been, or known, John James' parents.

2. Per land records and family Bible records, we know some of the sons of the "original" Thomas such as Elias, William, Moses and Eli, lived in western South Carolina and northeastern Georgia in the same counties that John James lived in. These counties are next to each other on the current Georgia and South Carolina border.

3. John James received a land grant in Hall County, GA, in 1820, six years



before Elias Allred (son of Thomas) received a land grant for land in the same county. 4. The names Thomas and Patterson reappear over and over again in the John James' family tree. The Patterson family was very prominent in Randolph County, marrying into the Allred family, eventually inheriting or buying some of the original Thomas and John Allred land.

5. Note the photo of Reddick and Reddin Allred on page 8 of this issue. They are great grandsons of Thomas. Notice the family resemblence.

The August 26, 2001, NBC National Television News broadcast a feature on **Kathy Allred**, U.S. Forest Service Lead Pilot when she was working with the airtankers near LaGrande, OR. ### Olympic Torch

Four Allreds are among 900 torchbearers who will carry the Olympic flame on its four-day 1,050 journey through Utah. The torch enters the state on February 4 and culminates February 8 with the lighting of the Winter Olympics caldron at Rice-Eccles Stadium during the Winter Olympics Opening Ceremony in Salt Lake City.


Carl was center on the basket all team and Clay was right forward and team captain.

Carl Allred later worked for the Atomic Energy Commission and then the Soil Conservation Service.

Clay Allred was a landscape architect and city planner. He worked for various city, county and states agencies. He ended his career as assistant planning director for the City and Borough of Juneau, AK.



Governor Allred is not pulling his punches in this campaign. He is fighting and fighting hard for good government in Texas.



# The Allreds Who Settled Sanpete County, Utah

Each year the Manti Chapter of the Daughters of Utah Pioneers (DUP), honors a family who were among the early settlers of Sanpete County in Central, Utah.

In 2001, the Allred Family was honored. The first Allred into the valley was James Tillman Sanford Allred, son of James and Elizabeth Warren Allred. Manti was founded in 1849 and was the first settlement in this county. In the fall of 1851, James and Elizabeth joined their son in Manti for the winter.

On March 22, 1852, James and his party choose land along Canal Creek 16 miles northeast of Manti. Today it is called Spring City.

History House in Manti had an Allred exhibit from Memorial Day through October. On Saturday, October 13, the DUP invited Allred Family members to a day of activities.

Registration at the Manti Tabernacle offered an opportunity to get to know newly found cousins. A tour was given to the Temple Stone Quarry. Keith Mackay of the State Stone Corp., Salt Lake City, directed the tour. We began at the Powder House where a monument in honor of E. L. Parry has stood since 1888. Oolite is the main stone of the quarry. This stone has been used for a variety of buildings in the area. Pioneers removed the stone from the edges of the quarry with hammer, chisel and black powder and transported it by pulley, animals and wagon to temple hill. The quarry has been drilled to the depth of 17 feet. The Hurst Castle in California and the Sheraton Palace in San Francisco are just a couple of the great buildings which are built from oolite.

It is still a working quarry. Black powder is still used to extract the stone. The stone must lay as it is taken from the mountain to maintain its strength. The group gathered at the Manti Cemetery for the Daughters of Utah Pioneers Wreath Dedication. Larry C. Allred, Rocky Mountain Allreds President, was the master of ceremonies. Members of the Battery "B" First Battalion of the 145th Field Artillery, who are descendants of the Nauvoo Regiment, posted the colors. Bonnie Ann Miller sang the National Anthem. Janice Ray, DUP Captain, was the speaker. She introduced Allred descendant, Alta Edwards Warnick, who placed the wreath and offered a few reminiscences of her pioneer life. Wallace E. Allred gave a prayer of thanks. There were a few quick pictures taken before departing for a wonderful lunch served by the DUP.

After lunch we went to the chapel at the tabernacle for the family meeting. Susan Barclay was the organist and Jane Braithwaite gave welcome comments. Yvonne Howell, a descendant of Reuben Warren Allred, another son of James and Elizabeth, was the opening speaker. Ruel Allred gave an overview of the Allred family and introduced the panel.


Dawnell Griffin spoke on the Allred Family in America. V. Con Osborne related the history of the family from Nauvoo to Utah, and Kaye Watson spoke on the Allreds in Utah. These were 13 minute histories. The group then sang *Carry On*. The panel answered questions. The congregation shared stories and histories. Many questions were clarified. Ned Allred gave the closing prayer.

The rest of the day was spent touring History House which includes a replica of a pioneer dugout. The Patton House and Manti School cabin were also on the tour agenda. The house holds many artifacts and the Daughters of Utah Pioneers showed the little one room cabin that was used for the Manti School.



### **Research Project**

In 1995, Dawnell Griffin compiled a large collection of Allred genealogical material and information on behalf of the Allred Family Organization. It consists of nine two-inch thick 3-ring binders full of information about the four "original" Allred men, John, Solomon, Thomas and William. Each binder includes family group sheets and copies of documentation such as land records, court records, wills, estate records and some family letters.

Our current AFO research project is to put copies of this collection in several major libraries across the United States. Libraries included on this list are: the Family History Center, Salt Lake City; the National Genealogical Society, Washington, DC; the National Archives, Washington, DC; and the Allen County Library, Ft. Wayne, IN, which is the second largest genealogical collection in the USA. The largest genealogical collection in the United States is in Family History Center, Salt Lake City.

The East Coast Allreds have already put a copy of this collection in the Randolph Room, Asheboro (Randolph County), NC. See page 1 of this issue.

Currently, we contacting these libraries and getting the requirements involved in submitting copies. We are collecting prices for copying and binding this collection. Plus we are investigating the costs for putting the collection on CD instead of copying and binding.

## **Marley and Allred Marriages**

from the book "Marley Families of North Carolina" by James M. Coffey, Jr.

### Rachael Marley Married Maloy Allred

Rachael Marley, daughter of John M. Marley and Nancy Kivett Marley, was born in 1836 in Randolph County, NC. She married Maloy Allred in 1854 in Randolph County. The family is listed in the 1860 Randolph County census. She was living next door to her brother, Haywood. In the 1870 Randolph County census she is listed as living in Liberty Township. After her death in 1877, two of the younger children, Nancy Jennie and Lulu, went with Nancy, younger sister of Rachael to Texas. At the time of the 1880 census, Maloy was in jail for making counterfeit whiskey labels. By this time the government had taken over the whiskey business. Both Rachael and her husband are buried in the Shiloh United Methodist Church Cemetery.

*Note*: Maloy's grave has not been located and it is not known where he is buried although many have looked for him.

### Haywood Marley Married Sylvania Allred

Haywood Marley, son of John M. and Nancy Kivett Marley was born February 17,1838, in Randolph County, NC. He married Sylvania Allred August 9, 1858, in Randolph County. Sylvania was born about 1836. (Sylvania's brother, Maloy, married Haywood's sister, Rachael.) The family was counted in the 1860 Randolph County Census in the household of Alsey Allred (Sylvania's mother).

This listing included: Alsey Allred age 70, Sitha A. (Cynthia) age 50, Eliza age 40, Haywood Marley age 22, Sylvania age 23, and Allen M. age 1. The 1870 Guilford County, NC, census listing included: Haywood age 34, Sylvania age 35, Allen age 11, Wesley age 9, Ruffin age 7, Jessie age 3, Alvis age 2, and Ann Allred age 56, a domestic servant. Ann Allred was Sylanvia's sister. In 1870 they were living next door to Franklin Marley, Haywood's brother.

### The Move to Kansas

Haywood and family, accompanied by Sylvania's sister, moved to Kansas about 1870. According to Haywood's obituary, Sylvania, two of their children and Sylvania's sister, died shortly after they arrived in Kansas.

Haywood's obituary was published in the DeSota Eagle Eye, Johnson County, Kansas on July 6, 1916, page 1, column 5. It reads as follows: Haywood Marley, son of John and Nancy Kivett Marley, was born in Randolph County, NC, February 17, 1838. He was married to Sylvania Alred of the same county, August 12, 1858. Of this union were born six sons of whom three survive: Allen M., of Sawtelle, California; Rufus W. of Beagle (Miami County) Kansas; and Jesse F. of Eudora, Kansas. He and his wife and six children and sister-in-law moved to Eudora, Kansas, in 1870 and located in the Kaw Valley, two miles east of Eudora. Soon after settling there, his wife, two children and sister-inlaw sickened and died. His endurance was sorely tried by sickness, poverty and distress in the new country, but was much alleviated by the help of kind Quakers and newly made friends. # Diary

A look at Randolph County, NC in 1926 Local historian, Becky Bowman, compiled the Franklinville Diary, which is a wonderful collection of excerpts taken from the local newspapers published in Randolph County, NC. These excerpts give us a glimpse into the lives of our ancestors who lived during that time.

#### January 7, 1926

Worth Allred, who has been working at West Palm Beach, Florida, is at home for a few days.

#### January 28, 1926

C. L. Allred and L. H. Curtis made a motor trip to Apex Friday.

Mrs. Peter Allred spent Thursday with her daughter, Mrs. Ralph Kinney, at Ramseur.

William Curtis and Ray Allred, pupils of Franklinville High School, have opened up a café on East Main Street near the Masonic Hall. They keep open evenings after school and Saturdays and Sundays.

The C. L. Allred Grocery Store and Franklinville Drug Store have installed new frigidaires.

Messrs. Hobert and Worth Allred left Monday for Florida

#### February 18, 1926

Mr. Peter Allred has moved his family to his farm on Route 75 about half the distance to Ramseur on what is generally known as the William Burgess place.

#### May 13, 1926

G H. Cox, Misses Pauline Cox and Katherine Julian, C. L.Allred and sons Woosley and Joe and J. C. Phillips spent one day fishing last week in the Cape Fear River near Moncure steam power plant.

#### June 10, 1926


Mr. Oscar Henson and Miss Beulah L. Allred were untied in marriage at the home of Rev. J. D. Hackney Saturday evening. Mr. Hackney officiated. The bride is a daughter of Edgar Allred and the groom a son of C. E. Henson. July 15, 1926

#### July 15, 1926


Mr. John A. Hurley, of Camden N. J., Mrs. J. L. Sears and daughter, Miss Lillian, of Charlotte, and Mr. Clyde Allred and family of Mebane were registered at the Franklinville Inn last week, the guests of Mr. M. L. Hurley.

#### August 5, 1926

B. A (Balfour) Allred, B. C. Jones and Lacy Kinney have graded and graveled a road from near Lacy Kinney's residence running south by J. F. Allred's barn, thence southeast coming into Highway 75 near Dennis Allred's spring. That is a good road and is being used by the public it being a lead roadfrom the old Asheboro road to the state road. The county is also building a road from the covered bridge down the river to the state highway.



William "Bill" Mendenhall, who died about 1975, was mayor of Signal Hill, CA, from 1962 to 1970. He was born in Randolph County, NC. His family line was *William "Bill," Ida Martisha, William Franklin, Claiborne, John, William*.



### **Jonathan Allred Report**

Excerpt from the Research Report on Jonathan Allred (1772 - 1850) written by: Dawnell Griffin (May 1999)

Jonathan Allred, son of Theophilus Allred and Margaret Ann Chaney, was born November 16, 1772, Randolph County, NC. More than likely, his father, Theolphilus, died between 1782 and 1790, leaving his mother, Margaret, a widow.

### 1773 Inventory

On December 13, 1773, an inventory of bonds, bills and notes due on the estate of John McKee, deceased, former merchant of Orange County, NC, included the names of James, John, Solomon, Theophilus, Thomas and William Allred. In 1782, Theophilus appears on the tax list for Orange County, NC.

By 1790 Theophilus does not appear in the census records. A search has been made for land and probate records, but at this point there are no records to determine the exact date of his death.

No other children for Theophilus and Margaret Chaney Allred have been identified. A notation dated July 30, 1953, written in long hand states the following:

May 9, 1840, Thomas Tanner and Rachel Tanner wrote two letters on a large, double sheet of paper. One letter was addressed to Jonathan Allred and Nancy Allred and began "Dear brother and sister."

The other on the same sheet was addressed to Samuel Bowman and Elizabeth Bowman and began "Dear brother and sister" also. (This indicates Elizabeth was sister of Jonathan). Baley Allred old papers, J. W. Allred owner.

One would assume, at first glance, that both Elizabeth and Rachel were Jonathan's sisters. However, there are three entries in the Jonathan Allred family Bible that give birth dates for what appear to be three sisters: Margaret Stillwell, Rachell Stillwell and Elizabeth Stillwell. More than likely these were Margaret Chaney's nieces. Elizabeth Stillwell was married to Samuel Bowman and lived in Overton County, TN.

### 1860 Census

The 1860 Census for Livingston, Overton County, TN, lists 60-year-old Samuel Bowman as a farmer, born in North Carolina with real estate in Overton County valued at \$2,500. His wife, Elizabeth gave her age as 71 and stated that she also was born in North Carolina. A son, Allen, age 35, was born in Tennessee. Living next door were E. N. Bowman age 31, Methiah age 32, Martha A. age 7, Isaac T age 6, Amelia C. age 5, Robert T. age 3, George N. age 2, all born in Tennessee. I also have a photocopy of a portion of a land record that apparently included two tracts of land involving property that bounded that of "Josiah Bowman and Charles Allred" ... to a conditional corner made by said Bowman and Allred.... In 1830, Samuel Bowman was witness on a land deed involving Jonathan Allred and which is hereafter presented. Family oral history claims that when Margaret Chaney came to Overton County with her son Jonathan, she brought a little girl with her. More than likely this was Elizabeth Stillwell, her niece.

#### **Stillwell Children**

Believing that the Stillwell children were left orphaned, I checked the probate and land records for Randolph County and was able to locate one solitary document. On the first day of April 1825,

Alexander Gray and Jesse Harper were involved in a land transaction.

#### **Land Transaction**

Apparently Seth Wade, then deceased, had conveyed a tract of land in the Western District of Tennessee to Alexander Gray on the 3rd of June 1824. It was part of a grant or warrant in the 12 district, fourth range, eighth section..."and whereas the said Seth Wade by the deed aforesaid conveyed to the said Alexander Gray all his right, title, interest, estate, claim and demand both at law and in equity of in and to the Estate of Thomas Stillwell late of Johnston County in North Carolina deceased and all his right title interest estate claim and demand of and to a certain suit instituted by the said Seth Wade in the Court of Equity for Randolph County against Elenor W. Stillwell and Philip Raiford of Johnston County aforesaid the administratrix and adminstrators of the estate of the said Thomas Stillwell deceased...." No conclusions can be drawn at present, but research is continuing.

In 1880, there are four males and four females living in the household of Margaret Chaney. Possibly, the oldest male, over the age of 45, was her father, Frances. The male 26 -45 would have been Jonathan, but the remaining members of the household have not been identified.
