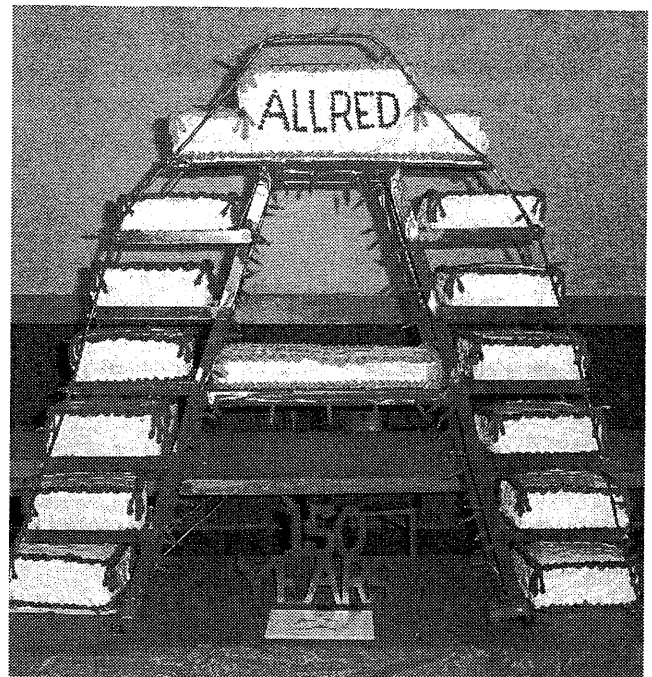
Celebrate 250 Years of Allreds in Randolph County, NC

Solomon Allred received his first land grant March 10, 1752. This is the oldest known Allred land record and the first documented proof that the Allred family was living in North Carolina. The celebration of this land grant is planned for September 6 - 8, 2002, Randolph County, NC.

For those who can arrive early, the North Carolina State Archives in downtown Raleigh is the site of the activities on Friday, September 6. There you can see the original wills and estate documents written by Solomon, John, Thomas Allred, Jeremiah York and William Trogon.

Texas Reunion October 12 - 13, 2002 Keller, Texas

Our Texas Allred reunion began as a way of getting the descendants of Calvin (1871-1951) and Ellena Allred Rowland (1882-1973) together. Ellena descended from the "original" Thomas who first appeared in North Carolina land records in 1755. The first two reunions were held in Calvin and Ellena's hometown of Quanah, TX.

In October, Allreds from many different branches of the family tree are expected at the reunion in Keller, TX. Keller is located about 30 miles north of Fort Worth on Highway 377. DFW International Airport is approximately a 20 minute drive to the reunion site.

The Senior Center, 600 Johnson Dr., Keller, is the reunion site. The activities begin at 1 p.m. on Saturday, October 12, for a social "meet and greet" afternoon. Bring your family photos and family history information to show off to everyone. A potluck supper follows. Allred DNA Project

There are many questions about the Allred family that no one has been able to find the answers for. Four of my favorite questions are:

1. Those first four Allred men who appeared in North Carolina in the 1750's: Thomas, John, Solomon and William, were they brothers?
2. Jeremiah York lived near Solomon Allred in Chester County, PA (just south of Philadelphia) in the 1720's. Jeremiah lived near those four Allred men in Randolph County, NC. Coincidence, or were they related?
3. Were these men descended from the Allred family of Eccles Parish, Lancashire, England?
4. Many Allred and York families have not been able to find documentation linking them back to any of these four Allred men or Jeremiah York. Are these "mystery" families related to us also?

Science has progressed to the point that DNA is now able to answer these questions. The DNA test will tell participants if they have an ancestor in common and a range of generations back that ancestor is on the family tree. Example: Let's say one of John's GGGGGGGrandsons and one of Solomon's GGGGGGGrandsons are tested. Their

tests show that they a common ancestor seven generations back. Then we will know that John and Solomon were brothers.

This DNA test is a saliva test using a tool that looks like a giant cotton swab that you run around the inside of your mouth. To read more about the test kit, go online to: www.familytreedna.com/kit.html.

Participants must be male descendants from an all male descendancy line. As part of the Allred DNA Project, participants will be charged a reduced price of \$99 per participant.

Family Tree DNA (www.familytreedna.com), a Houston, TX, company that specializes in DNA testing for genealogy purposes is the company selected. Visit their Web site to learn more about DNA testing and the Family Tree Reconstructions projects.

We Own

The front page of newsletter issue No.51 told you about finding the graves of the "original" William Allred and his wife Elizabeth Diffie Allred. These graves are located in the long abandoned Allred-Trogdon Cemetery in Randolph County, NC, near the land where William and Elizabeth lived. An extremely exciting find - one that we're still celebrating!

Now we have even more news to share. Even before we knew William and Elizabeth were buried in this cemetery, members of the East Coast Allreds were already talking about ways we could clean up, preserve and protect these graves. After the discovery, we were "on fire" to gain possession of the cemetery and preserve it for future generations. Through discussions with the landowner, 84 year old Alton Garner, we learned he was talking to a local developer about possibly selling the land - including the cemetery. Yikes! That might mean houses, apartments, a shopping center built beside or around the cemetery - limiting or maybe even eliminating our access to it. A careless bulldozer operator could easily destroy the entire cemetery in a matter of minutes. Yes, destroying a cemetery is against the law. But, out in the woods where no one is watching - let's face facts. It happens all the time.

Plan Generated

So, ECA members put their heads together and immediately began making plans to gain possession of the property. Dennis York used his investigative skills to research the deeds and educate himself on cemetery ownership, tax laws, tax-exempt status (application process) and how to incorporate the ECA. James Eugene Allred used his friendly "good ole boy" skills and began talking to Mr. Garner about possibly giving the cemetery to the ECA in exchange for a tax credit. Harlan and Becky Allred Sexton found a surveyor and arranged to have the cemetery surveyed - quickly. (And they paid for

it!) The rest of us met with them, exchanged numerous e-mails and phone calls every day, consulting, advising, asking and answering questions.

Within a few days, Dennis had filed the necessary paper work to have the ECA incorporated. Our new official name is East Coast Allred Family Association, Inc.

Dennis then began the almost overwhelming job of filling out all the paper work needed to apply for Federal Tax Exempt Status 501(c)3. A detail filled 36-page document! In a marathon six-hour meeting, Dennis, James Eugene, Harlan, Becky, Linda Allred Cooper, Nancy Martin and Hollis Allred (with W. Darrell Allred on the phone part of the time) worked through this form, answered all the questions, and had it in the mail the next day.

Bylaws Created

Three days later Dennis, with the editing skills of Nancy and Darrell, had created a brand new set of Bylaws for the ECA. In less than two weeks, we had accomplished work that usually took several months.

Eugene and Dennis presented everything to Mr. Garner - then we all sat back and held our breath. Would he give us the cemetery - or not? We waited for over a week - then the phones began ringing.

YES! The cemetery was ours! But, there was a "catch," a small problem. Although we had applied for the 501(c)3 tax exempt status, we had not received approval yet. Therefore, we couldn't give Mr. Garner a tax credit for his "gift" of the cemetery.

Genealogy Society

Once again, Dennis came to our rescue. He quickly contacted the Randolph County Genealogy Society and asked if they would take temporary possession of the cemetery.

The RCGS is already 501(c)3 tax exempt and could give Mr. Garner the tax credit. Then, when the

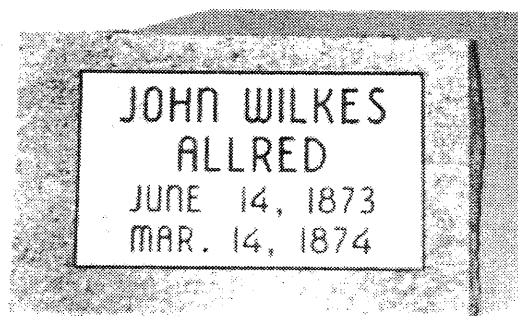
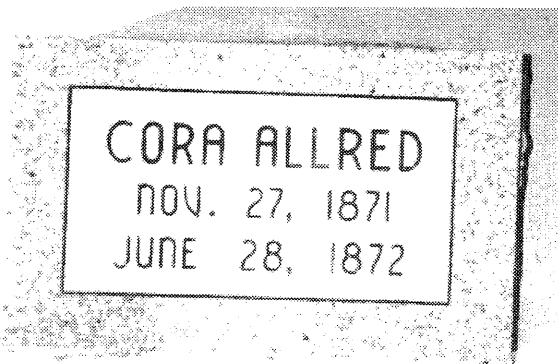
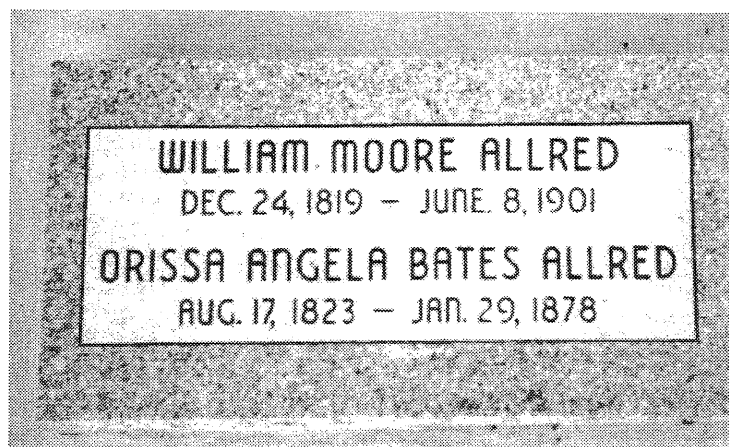
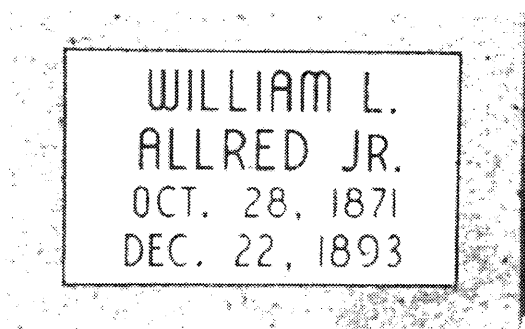
ECA is approved for 501(c)3 status, the RCGS will transfer ownership of the cemetery to us. When the RCGS agreed, Dennis and James Eugene quickly met with a lawyer to have the necessary legal documents drawn up. With a Notary Public in tow, they went to visit Mr. Garner and had everything signed and notarized. Everything was filed in the Register of Deeds office the next morning and Hooray! We own the cemetery.

What a busy few weeks that was! Like a whirlwind! During that time we also had two meetings with the entire ECA membership present to discuss and approve every thing. Thirty to 35 members were present each time. Have you ever tried to "round up" that many people on short notice - and get everyone to agree on something? But, we did it!

The graves of William, Elizabeth, and everyone else buried there are now ours to preserve and protect. The cemetery is a big responsibility, but one that we are very proud to take on.

Many, many thanks to everyone involved in the process! It was inspiring and exciting to see all the teamwork. Now everyone reading this should make plans to visit Randolph County and see "our" cemetery.

Restorations in the St. Charles, Bear Lake County, Idaho Cemetery



While reading the *Allred Family Newsletter* for Spring 2002, No. 50, I could not help but think that so many of our ancestors tombstones are in need of repair or replacement. Over the last year, Erma R. Allred Pugmire, daughter of Ernest Wilkes and Orissa Elizabeth Rich Allred had stones replaced and another reset.

These stones are all in the St. Charles, Bear Lake County Cemetery, in southern Idaho. The three single stones were only marked by the funeral type markers set in cement. The double stone had been broken several times and was difficult to read. Mother said many times, "If someone will not replace and repair our ancestor's tombstones, when some of the older ones pass on, no one will know who or where the family has been laid to rest.

The stone for William Moore Allred and his wife, Orissa Angela Bates Allred was reset. William Moore Allred was born in Bedford County, Tennessee, to Isaac Allred and Mary Calvert Allred. The line is William Moore, Isaac, William, Thomas.

Petition For A Divorce in 1842

In the Spring 2002 issue of the Overton County (TN) Historical Society's (OCHS) Genealogy Newsletter, page 17, you'll find the following divorce petition. As you know, divorce was very unusual in 1842, which makes this so interesting. This court case was found in the Overton County Court Minute Book 1839 - 1844 which was transcribed recently by Mrs. Vonnie Looper Munnerlyn for the OCHS.

vs.

David (or Daniel) Allred

Be it remembered that this cause came on to be heard upon the 29th day of June 1842 before the Honorable Abraham Caruthers, Judge, presiding upon petition proof and judgement for confessed when it appeared to the court that a copy and subpoena had been regularly served upon Defendant that petition had been taken for confessed that defendant and petitioner resided in Overton County at the time of their separation and had for more than two years before their separation that defendant willfully and maliciously abandoned petitioner as charged in petition. It is therefore ordered adjudged and decreed by the Court that the bonds of Matrimony heretofore subsisting between the said Susan and the said David (or Daniel) be annulled and for nothing esteemed and that the said Susan be restored to all the rights and privileges of a feme sole and that the defendant pay the costs of this proceeding.

The AFO exchanges newsletters with the Overton County (TN) Historical Society. As you can see from the document above, this arrangement benefits both organizations. Whenever the

OCHS prints information about the Allred family, it is either passed along via this newsletter, or posted on the AFO web site (www.allredfamily.org). The copies of the OCHS newsletter are then presented to the Randolph Room (Asheboro, NC) where researchers can access them.

Allred, Tennessee

Allred, Tennessee, lies at the confluence of Puncheon Camp Creek and the West Fork Obey River. Indians camped at Puncheon Camp for years. They would hunt, fish, cultivate the rich river-bottom land, and make arrows from the flint outcrops in the area. Allred formed as a community around 1900 as the first large-scale bandmills moved into the area to process the virgin timber from the native forests.

Allred lies halfway between the foot of Cub Mountain to the south and Alpine Mountain to the north. The tiny community lies in a deep valley at 900 feet above sea level with the Cumberland Plateau escarpment towering on three sides with elevations exceeding 1800 feet. The setting makes for possibly the most picturesque part of Overton County. There is gentle rolling farmland and the majestic West Fork Obey River at the base of the valley.

Allred was named after the Allred family, who were among the first permanent settlers of the rugged area. A trustee of the University of Tennessee, Ernest Allred purchased several thousand acres of mountainside and valley land and settled into the area just after 1900.

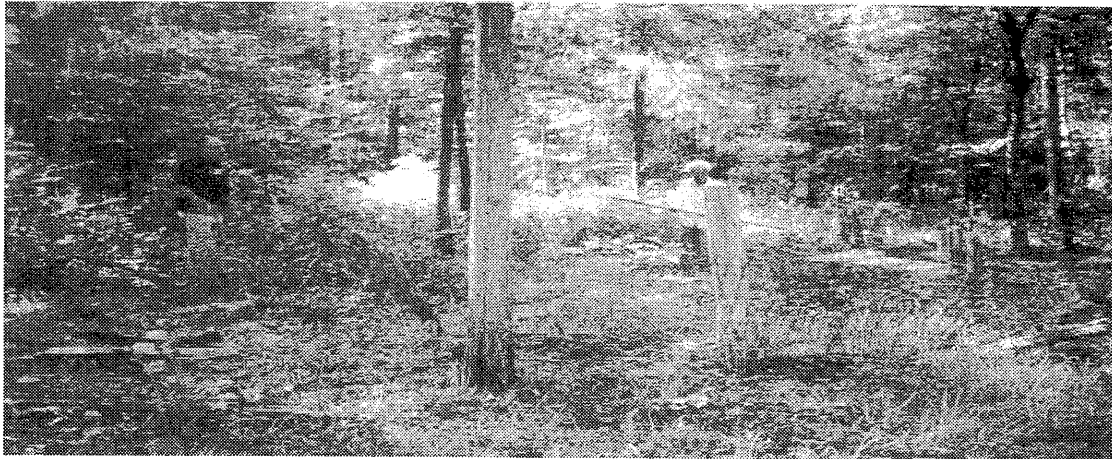
Descendants of the "original" Solomon Allred settled this area of Tennessee. Overton County is 434 square miles located 90 miles north and east of Nashville. The 2000 population was 20,118. For further information on Overton County see www.overtonco.com.

Restoring a Family

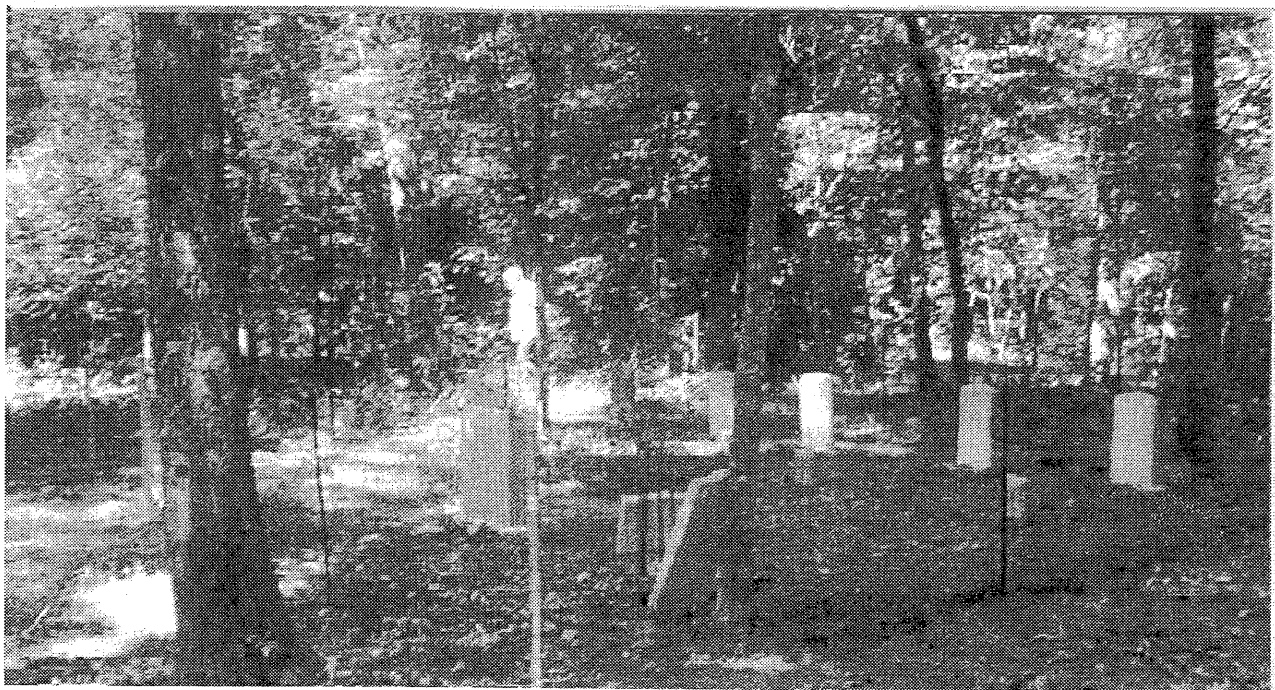
Allred cousins gathered in Lincoln County, Mississippi, June 1, 2002, to spend a day cleaning and restoring the Allred Family Cemetery located there.

This cemetery is located back in the woods off

Gene Road, about 12 or 13 miles southwest of Brookhaven, MS. Ezekiel Allred (1816 - 1884), his second wife Louretta Wainwright Allred (1841 - 1926), and several of their family members are buried there.



In this “before” photo, this abandoned cemetery had been neglected and was almost entirely lost in the woods, covered with weeds, vines and underbrush. The “Crew” was made up of cousins: Hazel Lucille Davis, Rodney Elwood Allred, Robert Lee Anderson, Rodney Elwood Allred, George Ezekiel Allred, Thurman Leland Allred, Beverly Sue Pogue and Daisy Adele Davis Pogue - all descendants of Ezekiel. The hard work took all day, but look at the results in the photo below! The cemetery is clean and neat, tombstones repaired, cleaned and re-set, and a new fence surrounds it, protecting it from the forest creatures.



Cemetery in Mississippi

Ezekiel was the son of Azariah (also called Ezra) Allred who is thought to be the son of Phineas. Phineas was the son of the "original" Solomon. As you know, the "original" Solomon Allred died in Richmond County, NC, in 1782. His son, Phineas, disappeared from North Carolina land records after the 1800 census. He next appeared in the 1810 census for Barnwell County, South Carolina, living near his brother, Jonathan. Per this census, Phineas had children, but unfortunately, their names are not listed

anywhere. However, Azariah soon appears in records and seems to have close ties to Phineas, leading us to believe he was Phineas' son.

Azariah, his father-in-law, John Bowlin, and their families moved to Mississippi



in 1810, documented by Georgia passports needed to travel through "Indian Territories." Azariah's son, Ezekiel, was born in July 1816 in Franklin County, Mississippi. The family remained in and around this area through today.

Letter Written October 19, 1849

To Solomon and Mary Allred from their son and daughter-in-law
Thomas and Ruhannah Allred

Thanks to Sarah Lehman of Clemmons, NC for sharing this letter.

To Solomon Allred, Robertsville, Tennessee

Shelbyville, Ind. October 19th 1849

Dear Father & Mother

Your letter of the 18th of September last has been received and we were glad to hear that you were all well at that time. We are well at present and have enjoyed good health generally.

In reference to your proposition to me and the other brothers concerning one or the other of us coming to live with you and take the farm would suit me very well. It would be a great help to me. Also it would afford me great pleasure to be with you and render you all the comfort and assistance I could in your helpless and declining years.

But still I don't see that I can possibly come and comply with the proposition because I now have a large family of small children and it is so far to move and my circumstances are such that I do not feel my self able to bear up under the necessary loss and sacrifices in fixing up to move and to under go the expense of the traveling with my goods and family. In short I am to poor to come just now.

The health of this country has generally been unusual good the past season and a fair average of all kinds of crops except what which was cut quite short by the ____ produce bears fair prices. Corn 30 cts - potatoes 20 cts - Flour \$3.00 per cwt, wheat from 60 to 90 cents per bu, ____ 3 cts pr pound. We have a rail road now in operation to our town from Madison on the Ohio and the cars make daily trips. They place every morning and return in the evening.

Peggy Montgomery and family are well. Jackson Aldridge and myself will likely be out to see you this winter some time to see unless we get disapointed in our calculations we are talking that way now. I wish to be remembered to John Keys and William Tunnell and all my ____ friends. Hope this letter will find you all very well and that I will still hear from occasionally. I want you to write to me certain so soon as you get an answer from the other two boys. As nothing more at present but remain your affectionate Son and Daughter until death

This Indenture made the twenty sixth Day of June one Thousand seven Hundred and Ninety six Between Joseph Bar of the County of Franklin and State of Georgia of the one part and William Allred of the County & state aforesaid of the other part Witnesseth that the said Joseph Bar and in consideration of the sum of one Hundred pounds lawful Money of said State to him in Hand paid by the said William Allred at or before the sealing and delivery of these presents the Receipt whereof is hereby acknowledged hath granted Bargained sold Released & Confirmed and by these presents doth grant Bargain sell and Confirm unto the said William Allred all that tract or parcel of land containing seventy five acres be the same more or less Situate Lying and being on the Waters of Leatherwood in said County of Franklin being part of a tract of Land Originally granted to Jacob Pennington and conveyed from him the said Pennington to Duncan Cameron & from him the said Cameron to Joseph Bar which will appease by the different Conveyances grant Bearing date the thirty first Day of December one Thousand one Thousand seven Hundred and ninety five signed by his excellency George Matthew then Governor of the State of Georgia which will more fully appear by references being had the original grant the same being part of the tract Conveyed from D Cameron to Joseph Bar being the lower part of said tract adjoining Spencers line on the East North by Vacant Land and continues up said Creek of Leatherwood to a conditional line at the known main fork of said Creek and run Parallel with the lower or Spencers line & South & Southwest adjoining Dunnagins Land - Together with all and Singular the Rights Members and appurtenances thereof to the said William Allred all that tract or parcel of Land belonging as in any wise appertaining with the Remainders Reversions Rents issues and profits thereof and every part thereof To have and to hold that parcel of land and every thereof to the said William Allred his Heirs and assigns forever and the said Joseph Bar for himself and his Heirs and assigns the said tract of Land on the premises aforesaid and every part thereof unto the said William Allred his Heirs and against all and every other Person and Persons whatsoever shall and will Warrant and forever Defend by these presents In Witness whereof the said Joseph Bar hath hereunto set his Hand and seal the Day and year first above Written Joseph Bar

William Allred was the second son of the "original" Thomas. He married Elizabeth Thrasher/Thresher. The couple left Randolph County, NC, in 1787 with four young children, Sarah, Mary, James and Elizabeth. Their other children, Isaac, William, John and Martha were born in Pendleton County, SC, or Franklin County, GA. By 1796, the family was living in northern Franklin County, Georgia, (now either Stephens or Banks County) on the Leatherwood Creek near Currahee Mountain.

John C. Allred and Cora L. Giles were married May 7, 1882. I was told he worked in Greensboro, NC, for a short time at some point during their marriage. Perhaps that was the absence during which he wrote the following letter. The letter is especially significant because their sixth child was already a year old when he wrote this letter. Darrell Allred has a photocopy of the original manuscript of the letter.

February 14, 1891

From a friend whose heart is love

To: Miss C. L. Giles

Dear friend it is with feelings of love and gratitude that I take my pen in hand to drop you a few lines this beautiful and lovely day, being the day that we call Saint Valentine's day.

My Dear Love I am well and hoping that while writing these few lines that you are enjoying the same. This day brings forth things fresh to my mind that occurred in the past, it brings things to my mind that make my heart overflow with Love when I think of the Golden Moments we have spent together in the most loving manner that two persons could enjoy.

Of if I could see the smile of your beautiful face today it would sooth my fears, increase my hope and make me the happiest boy the world ever saw, but such cannot be the case today. I can only look at your beautiful portraits and gaze on them with tears of love. After all this does not satisfy my emotion. Your heart seems to me like it is filled with loving kindness. God in his tender mercy permits me to write to you this day these few lines. And if I have written or will write you anything untrue I hope he will not permit me to even write to you again. I love to linger in my mind the words you have said to me. With these few lines I close my letter with these few verses hoping they will be read with your warmest love.

Please turn to the alphabet and see if you can find the first three letters of my name. Please answer soon as possible. And this is the end.

Letter to the Editor

Dear Editor:

The Allred Family Newsletter is absolutely outstanding. I enjoy the historical information such as Pendleton District, South Carolina; Franklin County, Georgia, and The Allred Trek Westward, etc.

Thank you for the article on page 10 of the Spring 2002 issue (No. 50) on John Calvin Allred Jr. I believe I can identify John Calvin Allred Sr., B 1839 D 1925 and John Calvin Allred Jr., B 1858. They are the uncle and first cousin of my grandmother, Margaret Jane Allred, B 1862, Pickens Co., Georgia. She is the daughter of the Rev. William Brantley Allred, B 1862, Pickens Co., Georgia. She is the daughter of the Rev. William Brantley Allred, B 13 Feb. 1838, Hall Co., Georgia.

My genealogy records of the research I've done on my grandmother's lineage show that her father, William Brantley Allred and John Calvin Allred Sr. B 27 July 1839, Hall Co., Georgia, were brothers. They were the sons of Miranda Allred and Delilah Free Allred. They are found on the 1850 census of Hall County, Georgia, as 11-year-old and 12-year-old children. Ten years later, the two brothers are found next to each other on the 1860 census of Cherokee County, Georgia.

William Brantley Allred and John Calvin Allred Sr. had six younger sisters and one younger half-brother. Their names are: Mary Carolina Allred B 1841 M John Bolen; Margaret Elvina Allred B 1843 M William Whitfield; Martha Calvania Allred, B 1845 M Louis Oliver; Sarah Jane Allred, B 1846 M Louis Oliver; Sarah Jane Allred, B 1846 M Benson Bridy; Celia Ann Allred, B 1848; Elizabeth Catherine Allred, B 1850 M Alfred Cochran and Elias Simon Allred, B 1855 M Beverly Adams.

Their father, Miranda Allred, was born 17 April 1814, Randolph County, North Carolina, and died in 1905 in Jasper, Pickens County, Georgia. Their mother was Delilah (Lila) Free born about 1815-18, Lexington County, South Carolina, D about 1851.

Miranda Allred was a grandson of the Revolutionary War soldier, Elias Allred, B May 1758 in North Carolina and Mary (Polly) Rigby Allred. The 1827 school records of Hall County, Georgia, names Miranda's mother as Mary Allred. His father's name is unknown to me.

My records show that the correct lineage of John Calvin Allred Jr., the subject of the page 10 article, to be (John Calvin Jr., John Calvin Sr., Miranda, Mary, Elias, Thomas).

Long-lost "Signature" Quilt Returned to Church

Eddie Clay and Carolyn Allred of Franklinville, NC, collect quilts. Currently they have about 300. One of the quilts they purchased about four years ago on a local radio swap shop for \$25 was returned to the original owners.

The "signature" quilt, made in 1947-48 by the Ladies Auxiliary at Franklinville Pentecostal Holiness Church was missing for a long time. It was not stolen or misplaced, just missing.

Signature quilts, sometimes called friendship quilts, were popular as early as the 1830s. There were more than 136 signatures on the quilt he returned to the church. The quilt squares originally sold for 50 cents each, with the signature of the purchaser embroidered on each square. The quilt was probably fashioned as a fund-raiser to assist the cost of adding on to the church building.

After the quilt was purchased, he recognized several of the names on it. He met someone who went the church where the quilt was made. He requested permission to return the quilt to the church.

The quilt is old and worn with threads missing and a torn back. It is priceless to the members of the small church.

The return by Eddie Clay Allred has sparked memories of those who signed the quilt. Return of the 54-year old quilt has stirred such interest that the women of the church are in the process of making another quilt.
