# Let's Take Another Look

Let's take another look at what we already know about the Allred family and some of their neighbors during the period 1720-1752. Although we have learned a great deal about the family over the past few years, there are still many "unknowns" that we need to figure out. So, let's back up and take another look at our questions.

It is very important to keep neighbors / friends / collaterral families in mind as we continue searching for clues. Since it appears the Allred family did not leave much paperwork behind - maybe these other families did and these clues will ultimately tell us more about our family. Here are some questions that need to be answered:

Who was the **Enoch Davis** (Jr?) who witnessed the wills of **Timothy Cude**, **John Allred** and **Thomas Allred**? We know there was a Enoch Davis in Frederick County, Virginia, at the same time the Yorks, Allreds, Trogdons and others were there because of this court minute entry: from "**Frederick County Virginia Minutes of Court Records 1743 - 1745**" by John David Davis (Heritage Books, Inc.) p. 99 and p. 121— Rebecca Edgell, of Simon Edgell, deceased vs. Enoch Davis, debt. Enoch Davis shows up in several records of

Randolph County, North Carolina. Who was this man and what was his connection to the Allred family?

In that same book, P. 137, is the following: "on motion of Samuel Earle, John Rout made overseer of road....tithables belonging to Lord Thomas Fairfax, James Seaburn, Widow Borden, William Remy, Edward Rodgers, Jacob Peck, Edward Corder, Thomas Postgate, John Painter, James Burn, Thomas Hooper, John Gregory, Richard Gregory, Benjamin Gregory, Samuel Earle & John Oldrage." Is John Oldrage actually John Allred? Could this be the same John Allred listed in the court document below?

Who was **Samuel Finley**? What was his relationship to **John (Johnnie) Allred**? We know that some time in the early 1730s, Samuel Finley left Chester County, Pennsylvania, and moved to Prince George's County. He died there in 1737 leaving only an oral or nuncupative will. It was dated 16 Oct 1737, and it was proved in court on 2 Feb 1737/38. In his will, Finley leaves his entire estate to "**Johnny (Allred) Aldridge**" but does not say who this Johnny Aldridge is, or where he lived. Henry

# 16<sup>th</sup> Century Birth, Marriage and Death Records of Eccles Parish, Lancashire, England

During the first half of 2004, 20 members of the AFO spent countless hours combing through microfilm copies of original documents. Each time the surname Allred (in various spellings) and/or Pemberton was found, that document was copied. Below you'll find those record copies. We welcome your contributions, thoughts, and research efforts if you would like to join us in future research projects.

#### **Book Preface**

The Parish Church of Eccles lies four miles to the west of Manchester in the midst of a huge Parish bounded by the parishes of Manchester, Prestwich, Radcliffe, Bolton, Leigh, and Winwick; the southern limit being the river Irwell.

The Parish originally contained the townships of Barton-upon-Irwell, Clifton, Pendlebury, Pendleton, and Worsley, and comprised an area of 22,028 statute acres, ten miles long by five miles broad.

In the Whalley Coucher Book there is mention of a confirmation of a grant of a fourth part of the church by Albert Grelli, - this must have been in or prior to 1185, the probable year of his death.

The volume here printed is the earliest existing Register. It measures 15 inches by 5 1/2, and consists of 132 leaves of parchment bound in leather, the entries, generally well written, are confused in a most extraordinary manner, and the greatest credit is due to our Editor for unravelling the difficulties. It may confidently be asserted that the present issue will reveal much which even the most careful search of the original would never have discovered.

The Episcopal Transcripts, 1610 - 1632, have been compared with the original Register - a most toilsome process in the present instance. Our thanks are due to the Vicar of Eccles for his ready assent to the transcription, printing and publishing of the Volume, and also to the every-courteous Mr. Price of the Episcopal Registry at Chester.



### Randolph County Allred Reunion

September 12 - 14, 2008

Saturday, September 13, 2007 Early activities September 12 and 14 Grays Chapel School Old Liberty Road and Hwy 22 Randolph County, North Carolina

The American Civil War 1861-1865 is the theme for the 2008 Randolph County Reunion. Did you know absolutely no one in North Carolina voted for Abraham Lincoln in the 1860 election, yet North Carolina was the last state to secede from the Union? Did you know Randolph County was the site of the final announcement that the War was over? Did you know that a large number of our ancestors left North Carolina to settle in Indiana after the War? Why? How did the War effect our peace-loving ancestors - were they able to avoid the conflict? These facts and many more will be revealed as we celebrate this important segment of our American History.

Friday, September 12, we will visit Bennett Place. You probably think of Appomattox when you think of the end of the War. But, the actual final surrender took place at Bennett Place in Durham County, North Carolina. On three separate occasions in April 1865, the Union and Confederate generals struggled to come to mutually agreeable surrender terms at

the home of James and Nancy Bennitt (research indicates Bennitt is the correct spelling of the family name). Finally, on April 26, the Bennitt home became the site of the largest troop surrender of the Civil War.

We will also visit the site where the Confederate Army was encamped while the surrender negotiations were taking place right in Randolph County - where many of our Allred ancestors witnessed the end of the War! For many years later, Allreds and their neighbors found relics from the soldiers encamped there.

Saturday, September 13, is the Main Reunion Day. Everything takes place at Grays Chapel School in northeast Randolph County. There will be a Civil War encampment and small arms exhibition presented by local reenactors. Take a trip back in time as you talk to the soldiers and learn about their lives during the War. The welcome meeting is planned for 1:30 a.m., covered dish/pot-luck lunch at noon, genealogy presentation at 2:30 p.m., and an arms demonstration at 4 p.m.

Sunday, September 14, is our annual Tour of Allred and Historic Sites in the County. We will visit the original Allred lands which dates back to the mid-1700s and immerse ourselves in local history.

Enoch and Joseph Metcalf witnessed the will. We know this from a court proceeding which Joseph Chapline instituted in an Orphan's Court proceeding held in Chester County, Pennsylvania, on 30 May 1738. In this proceeding, Chapline set forth a petition to the court which was worded as follows:

"John Aldred having petitioned the Court Setting forth that being a minor and a Considerable Estate being left him by Sam'l Finley which if not timely taken care of may Suffer very much and therefore prays to be Admitted to Chuse his Guardian which is allowed of and the minor Nominating Joseph Chaplain of Prince George's in the province of Maryland who is hereby Admitted to prosecute & defend all Suits pleas and actions for and in the acct of the S'd Minor as the Law directs."

At the present time, I cannot tell you anything further about this John Aldred except that he was born between 1722 and 1738 (age estimated from the fact that per the court proceeding, John was a minor). Nor can I say anything about his relation to Samuel Finley.

A land grant in Randolph County, NC, dated 29 Dec 1762 shows John Julian, buying land (200 acres) near his brother Isaac. John died after 1762 and before 1779. His wife then married Thomas Allred of Randolph to whom he was married by mid-July 1779 according to a Frederick County, Virginia, land record which notes that on 12 Jul 1779: "a certain tract of land in said County, 458 acres on both sides of Back Creek, consigned to John Stonebridge of said County by George Julian, son and heir of John Julian, deceased, reserving one-third of said land for Elizabeth Allred, widow of said John Julian, for and during her natural life, and after her decease the whole tract to said John Stonebridge. Manuscript from Wilber C. Julian and Kathleen A. Julian, unpublished manuscript entitled, *A Julian Family History*.

We know the Thomas Allred who died 1809 had a wife named Elizabeth because she is named in his will. However, if she is the same Elizabeth who was the widow of John Julian who married Thomas Allred, she would not be the mother of his oldest children who were estimated to have been born beginning around 1745. Was she a second wife, possibly the mother of his younger children? If so, who was his first wife?

(Editor's note: we looked for a copy of this deed naming Elizabeth Allred, widow of John Julian, but were unable to find it. Researchers will return to Virginia and Maryland to continue the search. If you have a copy of this deed, please let us know.)

There is also the interesting marriage record listed in the **White** family Bible - <u>Isaac Julien</u> to **Barbara White** 10 Sep 1741 in Winchester VA dau of Dr Robert and Margaret **Hoge White**. Seven children given in order as Mary **Odell**, Margaret **Alred**, Catherine **Long**, Rebekah **Frazier** wife of a member of TN constitutional convention, Rene Julian, Abigail **Trogdon**, and Isaac Julian.

The White family Bible was copied by Isaac Hoover Julien of San Marcos, TX, and published in "The Evening Star" Winchester, VA, 7 Nov 1901. It states that Isaac was born 1714 and married when age 27 and died in 64th yr - Register of St Ann's Parish at Annapolis MD records Isaac's birth in 1716 The 10 Sep 1741 date for the marriage of Isaac Julian to Barbara White is cited in several sources. The record is cited in the book by Wilmer L. Kerns, Historical Records of Old Frederick and Hampshire Counties, Virginia (Revised) (Bowie, MD, 1992) p. 214. Cecil Odell's book *Pioneers of Old* Frederick County, Virginia (Marceline, MO 1995) p. 201 has this: "In 1741, Isaac Julian married Barbara White, daughter of Dr. Robert White and Margaret Hoge (daughter of William Hoge Sr. and Barbara Hume Hoge). Isaac and Barbara White were the parents of seven children and moved to Guilford and Randolph County, North Carolina. Daughters Mary married Nehemiah Odell (a Regulator), Margaret married John (Allred) Aled and Abigail married Samuel Trogden. They all moved and lived on Bush Creek, near Deep River, Randolph Co., North Carolina." The authority Odell cites for this is Rebecca Downey White's manuscript entitled "The Julian Family in Bohemia Manor, Cecil County, Maryland, 28 July 1745," Handley Library, Winchester, Virginia.

Does this give us the name of the wife of John Allred who died 1792? Margaret Julian Allred? That would certainly explain one of the Allred / Julian connections and some of the close connections to the Odell and Trogdon families.

## Letter to the Editor

Dear Editor:

I received issue number 73 of our newsletter and note the article on our blood kinship to Senator Barack Hussein Obama, Jr., by Ms. Cooper. The Cooper article has an error on page 13. Lines 15 and 16 of right column lists "oldest" daughter (of Margaret Isabel "Belle" Wright McCurry (listed as "Margaret") is Incorrect. Senator Obama's great-grandmother is incorrect. Senator Obama's great-grandmother Leona Belle McCurry Payne is the correct ancestor. See Allred Family Roster reference #030801020906.

The Allred/Obama pedigree I provided contains full names, is more concise and easier to follow than wading through a writing, as worthy as such might be. Perhaps you will publish this pedigree for purposes of clarity for all readers. You will note that I list "best known as" names by use of apostrophes ('Franky' 'Belle' 'Ann'). His mother used "S. Ann Dunham Obama: perferring not to use "Stanley," which was her given name. Thus, you'll see that I used S(tanley) 'Ann' Dunham on the pedigree. When seeking data on an individual it is important to know various variations in name over time so a researcher can readily see that two seemingly different names are, in fact, one and the same person. It's a simple matter of punctuations and styling when typing a name. Such a full identifying name need only appear once in a narrative, with a shorter name used throughout a given writing. I'm a writer and I do realize that the average person is not aware of such nuances, but the average reader has a better understanding of diverse nomenclature for any one person when such care in naming is employed. We all err from time to time but certain methods prevent some mistakes.

# **Historic Allred Hotel**

The Allred Hotel, 59 North Main in Spring City, Utah, has been restored by new owners, Mark and Vicki Allen.

The historic hotel was built by James Crisp, a farmer and stock raiser, who was born in England in 1851. He came to Utah in 1866 and came to Spring City in 1867. He first worked at several different occupations and then began freighting produce to the mining camps. Wealth followed. In the early 1880s, Crisp built this mansion on Main Street. In the early 1900s Crisp met an untimely death under the wheels of a piece of farm machinery after lightening spooked his horses. After his death, the big house was sold to Orson and Lorena Sorensen Allred.

Orson Allred was born in Slaterville, Weber County, Utah, in 1856. His father, Isaac H. Allred, moved to Spring City in 1860. In 1878, Orson married Lorena Sorensen, daughter of Peter and Anna Sorensen. Buying the Crisp home allowed the Allreds to open several rooms for boarding and they operated what came to be known as the Allred Hotel for 25 years. Salesmen, teachers, theatrical groups, politicians, sports teams and many others patronized the hotel.




The Crisp-Allred House is significant as one of the largest and most impressive examples of 19th Century vernacular building in Utah. The 1870 deed went to Ann Nield, daughter of Luke Nield. In 1874 the lot was sold to Marinus Lund for \$150. James W. Crisp bought the lot in 1880 for \$225. He built the house soon after the 1880 purchase date. Dances were held in the larger upstairs rooms.

The new owners restored the hotel and welcome guests. Those attending the June 28, 2008, Allred Reunion in Spring City are invited to schedule an appointment and tour the historic hotel now known as the Spring City Inn & Antiques. 





# The Mysterious Death of John T. Allred

John Tyson, Elisha, John, William

On February 29, 1880, the coroner, Tyson Trogdon, for Randolph County, North Carolina, deposed two witnesses to the death of John T. Allred. Below is a transcription of that record. The original handwritten copy is on the opposite page.

The examination of Wm. E. Allred of Randolph and Emiline Trogdon of Randolph taken before me Tyson Trogdon Coroner of the couty aforesaid this 29th day of February 1880 at Wm. E. Allred's shop in the county aforesaid upon the body of John T. Allred then and there lying dead to wit.

The said Wm. E. Allred maketh oath that he went down to his shop about three o'clock in the after noon that he saw John T. Allred's mule standing hitched near the shop. He thought strange of the mule's being there. He looked about and he saw a coat and hat lying on the dam near the pear head [pier head]. He stepped to the pear head and there was a person in the pear head that he thought was John T. Allred being dead.

Emiline Trogdon maketh oath that John T. Allred came to her house after a dog that he was very sober with not so much to say as common and looked considerably pale. He tied the dog with her help and went off riding his mule and leading the dog between two and three o'clock in the after noon which rope she described as being the rope that was around his neck in the pear head. Sworn to before me the day and year above written.

Tyson Trogdon, Coroner

Did some sort of mental illness "run" in this family? John Tyson Allred was born and raised on the original family land first owned by his great-grandfather, William Allred. William's family had lived on this land since 1753. Located along the Deep River between today's towns of Cedar Falls and Franklinville, the land was bordered by the Trogdons who were neighbors and extended family through marriage.

John Tyson's grandfather, John, had been declared a "lunatic" in the 1840s. John's son, Elisha, and son-in-law, Solomon Feree, had realized that Elisha was no longer able to tend to himself or handle his financial affairs and went to court to, in today's terms, take his Power of Attorney.

By studying the court records, it seems that John may have suffered from dementia or alzheimers.

After John's death, his son, Elisha, took most of his family and moved to the southern part of the county near today's Coleridge (then known as Moffitt's Mill).

However, John Tyson remained on the family land along the Deep River. He married Hannah York on September 27, 1853, and together they raised five children.

Knowing the family history of dementia or alzheimers, was that a possible explanation for why John Tyson chose to hang himself on that cold February day? Or was there something else wrong? We may never know, but it is an interesting story.
